Pay and Play Booking Card Holder Benefits – Winter Season Only

The Burnaby Tennis Club (BTC) is pleased to offer a Pay and Play Booking Card option for the public who enjoy playing tennis but find that a full membership option may not be suitable for them. The BTC Pay and Play Booking Card Holder is entitled to the following benefits:

- Access to dedicated Pay and Play Court 1 up to 7 days in advance on a pay-per-use basis at the prevailing court rate.
- Guests of Pay and Play Booking Card Holders will each pay a \$5 guest fee per booking that is booked 48 hours to 7 days in advance. No guest fee if a court is booked less than 48 hours in advance.
- Online booking is available

Rules, Terms and Conditions

The following rules, terms and conditions must be observed to receive the above benefits.

Court availability for dedicated Pay and Play Court 1 when booking up to 7 days in advance and access to available timeslots on Courts 2-6 when booking no more than 22 hours in advance.

Rules Violations and Consequences

BTC does not approve of the use of club courts for the purposes of unauthorized coaching*. Violation of this or any other rules may result in suspension or termination of Pay and Play Booking Card privileges. If you have any questions, please ask the BTC Staff. As a guiding principle, BTC strives to provide a safe and fair playing environment for all members as well as members of the public, and so reserves the right to modify these rules as necessary from time to time and without notice.

Definitions

The following terms used within this document are defined as follows:

- **Annual Member** – any player registered at the BTC in the membership categories of Adult, Senior, Junior, Intermediate/Student or Early Bird for the Winter Season and Summer Season. Excludes Pay and Play Booking Card category and Summer-only members.
- **Pay and Play Booking Card Holder** – a non-member of the Burnaby Tennis Club, who has purchased a Play and Play Booking Card to play indoors at BTC during the indoor Winter Season.
- **Unauthorized Coaching** – Coaching provided by BTC tennis professionals is authorized coaching at the Burnaby Tennis Club. All other coaching is unauthorized except for:
 - Public players may only coach their immediate family members, using the maximum allowable balls on the particular court (ask BTC Staff).
- **Winter Season** – the months of October to April when the bubble is in operation.
