She was very frustrated. After listening to her and explaining why we needed to do that vs the old method, she accepted the rational and said she would adjust and inform the others.

Saturday provided a good example of why we need better data/records of our court activities. Our washrooms were a mess and the courts were loaded.

Mayor Corrigan Meeting May 19th, 2016

The meeting with the Mayor couldn't have happened on a more problematic day for the Mayor. He should have cancelled our meeting, but he didn't! We had more than a 30 minute meeting/conversation and he said he'd be glad to meet again in the near future. That day he was Vice-Chairman of the Metro Mayors for the Region and that the Kinder Morgan decision was coming down a day earlier and he was preparing for the press, he still hadn't had lunch.

The **purpose of my meeting** was to understand his views on our plans for the future of BTC and the opportunity that we are unable to provide for SFU, Burnaby High Schools and Elementary Schools and to be able to compliment the Parks and Rec programs. I also wanted to learn where he thought Burnaby was in the discussions with Tennis Canada to see if it was the same as the conversation I had had with Tennis Canada a few days before.

Derek's legacy is the Burnaby Lakes Sports Complex and its future. The pool is being re-built, he is involved in the improvement to the Rowing Club complex and renovations and very much a fan of the Rugby Club as he has rugby playing days history in Vancouver. He met his wife at UBC and she was a competitive player out of the Hollyburn Country Club in West Vancouver. They played at our club but was not a member. He is good friends of Tub and Rae.

He was instrumental in getting the "Ty Kwando" Tournament (spelling) here after going to Seoul Korea to support the initiative. He wants to promote "Sports Tourism and all the benefits that brings. So the very positive feeling that he would like to see the Tennis Canada Complex built in Burnaby, but only if BTC is involved in the final complex and that it benefits Burnaby citizens.

He doesn't want to deal with a BTC Permanent Facility as long as we are in negotiations with Tennis Canada. He understands the dilemma and so I/we will now work along more closely with Tennis Canada to see what progress can be made and how BTC will or could or can benefit.

He would really like to see BTC be involved more in tennis programs for the Elementary Schools, High Schools and have more Public exposure, much like his favorite programs for Golf that have been going on for years and which he is fully behind with the Burnaby Golf courses and the Schools!! This is the future for keeping the Golf memberships at the Burnaby courses. He sees us doing the same.

Derek's passion is golf with his wife!!

He also would like to see us promote tennis in and with the Ethnic communities.

So, I will be meeting with Dean Pelletier and Dave Ellenwood to debrief them of my meeting with the Mayor and learn and more about the Tennis Canada progress. I will be meeting with Tennis Canada on their next visit expected in July. I will keep everybody informed.
