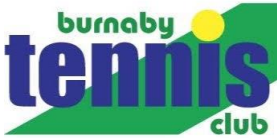

RULES AND RECOMMENDATION GUIDELINES FOR BURNABY TENNIS CLUB

Burnaby Tennis Club ("the Club") has put in place preventative measures to reduce the spread of COVID-19; however, the Club cannot guarantee that you (*or your children and/or your spouse*) will not become infected with COVID-19. By completing and submitting this waiver you agree to the following:

I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that I (and my children and/or my spouse) may be exposed to or infected by COVID-19 by attending the Club and that such exposure or infection may result in personal illness, injury, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the Club may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club employees, directors, independent contractors, volunteers, and program participants and their families.
